President's Message Phil Franey

Our mission is to promote the education and earned benefits of all retirees of Kern County, advocate the safeguarding and continuation of Kern County retiree pension and health benefits, provide avenues of support and information for Kern County retirees and beneficiaries, ensure proper and necessary representation on the Kern County Board of Retirement, and participate as an integral contributor in our Kern County communities' quality of life.

During a previous luncheon, a program was presented by Gordon Isen (661-868-1656) who heads the real estate fraud unit in the District Attorney's Office. His program titled "DON'T BE A VICTIM!" discussed not being a victim of fraud or a scam. Some of the more important points made by Gordon were:

- You are the boss of your money and property so be diligent and careful.
- Identify who you are dealing with is your best weapon – verify identity.
- If it seems urgent, beware. Don't let anyone rush you into anything.
- Get disinterested advice from someone you trust before you sign.
- Watch your stuff and inventory your valuables.
- Watch your friends and their stuff. Use the buddy system.
- ***If you have trouble or are confused get help from: Adult Protective services, District Attorney's Office, Better Business Bureau, law enforcement agencies, and stopfraud.gov.***
- Do not follow emails with website links; instead, if Interested, use a search engine.
- Day after your birthday, check: annualcreditreport.com

- Buy and use a shredder for all disposed documents.
- Get a secure mailbox.
- Sign all checks with gel ink that is difficult to chemically lift from checks.
- Beware of all prize offers and awards, calls asking for money, etc.

The National Center for Victims of Crime says that Americans age 65 and older are more likely to be targeted by scammers and more likely to lose money once targeted. The group puts the annual cost of financial fraud in the \$40 billion to \$50 billion range. So be very careful and make sure you trust those you deal with in any financial matter.

The REOKC membership health fair will be during the day (10:00A-2:00P) of our July 12 BBQ luncheon (free to REOKC members and their spouses). This year's health fair will be a similar format as last year. Steve Pettee of Pacific Group Agencies, Inc. (PGAI) is coordinating an effort to have representatives of various supplemental benefit providers at this luncheon. Pacific Group Agencies' Supplemental Benefits Program is a **separate program from that of the County's health insurance benefit program. The Supplemental Benefits Program is administered by PGAI, not KCERA.** The program is endorsed by REOKC to offer additional benefits to retirees and beneficiaries, such as legal services and other insurances to include: home and auto policies, dental, vision, pet, and accident/travel. Eric Barthel of Hub International, health care consultant for REOKC, will also solicit the services of local health care providers in offering health information and testing for cholesterol, blood pressure, etc. Similar to last year, retirees will be offered the health information and health screenings from such providers as Kaiser, San Joaquin Hospital, Bakersfield Heart Hospital and CSUB Nursing Program.

Every day our retirees and their families unselfishly volunteer their time and effort for community projects and causes. Many retirees and spouses have volunteered their time at the information desk in the Kern County Administrative Building lobby on Truxtun Avenue. We also thank

KCERA Retirement Board

“A retirement system board’s duty to the system’s participants and their beneficiaries shall take precedence over any other duty” (Section 17(b) of Article XVI of the California Constitution).

The KCERA Board (Board) is experiencing a busy 2016. Dealing with the management of investments, budgets, actuarial studies, audit reports, disabilities, and other pension administration programs takes a significant amount of time and effort. With more than \$3.5 billion in assets and over 17,900 members (retired and active), the administration continues to provide the necessary support to address the many operational efforts.

In June the following business was conducted by the Board and Committees: **Finance Committee** met to review and recommend approval to the Board the proposed Fiscal Year 2016-17 KCERA Operating Budget presented by Executive Director Gloria Dominguez and Retirement Finance Officer Sheryl Lawrence. The 2016-17 Budget of \$5.9 million is only 2% more than last year’s budget of \$5.8 million, due mostly to salary and benefits as well as some Board expenses. Key events during the 2015-16 Budget included three new board members, imaging/indexing old hard copy files, investment award recognition, and Assistant Executive Director Recruitment. **Investment Committee** met to recommend strategic asset allocation policy mix to the Board, and to discuss emerging market equity manager finalist presentation by Verus (KCERA investment consultant) and KCERA Chief Investment Officer (CIO) to include performing the necessary due diligence. **Regular Board** met to approve the consent agenda (routine and noncontroversial items); receive and file the presentations on Real Estate and Private Credit and 1st Quarter Investment Performance Review for the period ending March 31, 2016 presented by Verus; discuss and approve the Fiscal Year 2016-17 Operating Budget as presented by Gloria Dominguez, Sheryl Lawrence, and Finance Committee; adopt resolution of the Kern County Hospital Authority in KCERA as a District under current law; and hear designated staff and committee reports before adjournment.

As well as member benefit information, summary and some reporting information may be obtained from the KCERA website at www.kcera.org. For more detailed information, access to all public records on the preceding matters are available at the KCERA administration.

All members are encouraged to attend Retirement Board Meetings on the second Wednesday of each month.

PARTISANSHIP

My letter, "Partisanship disheartens World War II veterans," was published in the June 10, 2010, Bakersfield Californian and awarded "Letter of the Month." The letter is reprinted herewith and unfortunately remains current. The letter states:

I hesitated to write this letter because most Americans are good and decent people. This letter is not about good people. There are mean-spirited citizens in our nation so engrossed with prejudiced attitudes they will not admit to, nor recognize themselves in this letter

Rampant partisan hatred that grips too many citizens is far worse today than it ever was in the past. Single political reactionaries and others affiliated with partisan coalitions unashamedly behave hatefully toward political opponents and the leaders of our nation.

The U.S. is not the high-principled country that my comrades and I served during World War II. Tom Brokaw called mine, "The greatest generation." In a short time, the last of us surviving WWII veterans will be gone. It's disheartening to us to see our generation has failed to teach tolerance and civility.



Stop the partisanship This is a narrative of an incident that could occur today: Two American soldiers were near enemy lines, with projectiles bursting overhead. One soldier was mortally wounded when they dove into a ravine. The dying soldier begged his comrade to save himself. The soldier, trying to conceal tears in his eyes, held his dying comrade in his arms and would not desert him. Difficult as it is to comprehend, there are sicko political activists in our country today who would insidiously ask, "Was the dying soldier a conservative Republican or a liberal Democrat?"

Walter Stewart retired from the Kern County Public Works Department in 1992. He started writing for the TREND in 2005 and has written more than 60 articles over the years. Our special thanks go out to Walter for all his work in both preparing his articles and providing his own art work.
