# **KCERA Retirement Board**

"A retirement system board's duty to the system's participants and their beneficiaries shall take precedence over any other duty" (Section 17(b) of Article XVI of the California Constitution).

I hope everyone had a Merry Christmas and will enjoy a Happy New Year. The KCERA Board (Board) has completed a busy 2023. This TREND publication is being sent to all KCERA retirees and beneficiaries throughout the world. The following information is a brief recap of Board action and staff efforts during 2023, as follows:

April - a 2.5% Cost-of-Living Adjustment (COLA) was included in your monthly retirement payment. According to Segal Consulting (KCERA Actuary) the COLA is based upon a comparison with the annual average CPI (Consumer Price Index) for the Los Angeles-Long Beach-Anaheim Area. During this time the Board Meetings were opened to the public. The public still continues to have the option of listening to audio or access live audio and video of Board meetings in progress.

May - the Board approved the 2023-24 Budget. The \$8.8 million budget provides services for more than 23,000 members and over \$5.6 billion in assets. The largest budget category of staffing is 78% percent of the total proposed budget. Staffing requires \$6.9 million that is \$736,045 more than last year's approved budget of \$8.6 million. The increase is primarily the salary and benefits needed for a staff of 40 employees from the 41of last year.

In July - retired members and beneficiaries received the Board approved restructured SRBR benefit distributions intended to assist retirees in offsetting escalating health care and other costs of living. The Board has truly acted as a fiduciary in the reengineering of SRBR. An explanation of the Board approved restructured SRBR benefit program is provided at <a href="https://www.kcera.org">www.kcera.org</a> or by contacting KCERA Administration.

December - the Board approved the Annual Comprehensive Financial Report that presented the financial position of the Kern County Employees' Retirement Association as of June 30, 2022. The respective

changes in financial position were in accordance with generally accepted accounting principles. Some Actuarial Study and Investment Performance information is shown in this article. As always, more detailed information is shown at the KCERA website concerning Board agendas.

Last year, Board elections for Primary Retirement Trustee and Alternate Retirement Trustee resulted in myself and Robb Seibly being elected for another three-year term beginning in 2023, respectively. Robb and I will continue to perform our fiduciary duties professionally and ethically for KCERA members. Robb is able to serve on committees as a voting member and with Board meetings serves in my absence. I will serve as Chair for the 2024 year.

During the December Board meeting, Verus (KCERA investment consultant) presentation included the fund balance and investment performance (net of fees) for the period ending September 30, 2023 as follows:

Total Assets at market value - \$4,901,023,930

1 Year - -7.9%

3 Years - 5.6%

5 Years - 5.1%

10 Years - 6.3%

As of June 30, 2023, the actuarial assumption rate was stated at 7.00% (expected long-term investment return) and as of June 30, 2023 the current funding ratio of 68.7% (% of fund assets available to pay liabilities).

#### REOKC SCHOLARSHIP PROGRAM



In 2012 REOKC's Board of Directors established a scholarship program for our members' relatives who are in their senior year of high school.

For the first 4 years (2012 through 2015), REOKC awarded two scholarships of \$750.00 each. From 2016 through 2018 the scholarship amount was increased to \$1,000 and two were awarded each year. In 2019 and in 2020 REOKC awarded six and seven \$1,000 scholarships respectively.

In 2021 the Board voted to increase the scholarship amount to \$2,000 and awarded twelve in both 2021 and 2022. In 2023, after careful review of all applications, the Board decided to award thirteen scholarships of \$2,000 each.

From 2012 to 2023 your REOKC Board has awarded 64 scholarships to REOKC members' relatives for a total of \$106,000.

This program is just one of the benefits of being a member of REOKC. Applicants are not required to live in Kern County or California. So, if you are not yet a member, take time to complete the form on page 4 and mail it to us.

Detailed scholarship application information/forms are available on our website: www.reokc.org. Forms must be completed, printed, signed and mailed no later than April 15th each year.

REOKC membership applications are also available on our website along with useful information and important contact numbers. Membership dues are only \$2.00 a month which is automatically deducted from retirees' and beneficiaries' retirement pay.

Also, as a member, you will receive all six issues of REOKC's newsletter, the TREND, each year by mail or email. Its purpose is to keep retirees updated on issues involving their retirement benefits as well as current events.

Membership in REOKC is one of the greatest bargains Kern County retirees and beneficiaries can have! Benefits like the scholarship program can only happen with a robust number of members.




